

## Gilpin County Arts Association 2008 Entry & Notification Form for the Juried Show

- \* Artists may submit up to 3 pieces in Fine Arts and 5 pieces in Fine Crafts. Each of these 2 categories must have a separate Entry Form. For example: a CERAMIC bowl and a PAINTING must each have a separate Entry Form.
- \* Ther Category Guidelines are in the GCAA 62<sup>nd</sup> Annual Fineart Prospectus. Request from 303-319-4796.
- \* Enty Guidelines: Max size 5'x 5', max weight 300 lbs, Professional quality framing, ready to hang wall art; no glass chips or sawtooth hangers accepted. All sculpture and pottery should be level and sturdy.
- \* You may submit 1 image per 2-dimensional entry & 2 images per 3-dimensional entry. These may be:  
 35mm slides, properly marked (see Prospectus) or  
 Digital images in Jpeg format 300 dpi @ 4"x 6" = 1200 x 1800 pixels on a marked CD in a well-marked jewel case.  
 We will no longer accept photos.
- \* The Entry fee for the Juried Show is \$35. Make checks payable to GCAA.
- \* The fee for the non-juried Bin Art is \$10, you are limited to 10 pieces at a time and you must be accepted in the show.
- \* Your entry must include this completed form, art images as above, fees payable to GCAA and an appropriately sized and stamped SASE.
- \* Fill out both sections. The bottom half is returned to you with the judges' decisions.
